Environmental precautions

Kvoid dispersal of spilt material and runoff and contact with soil, waterways, drains and sewers. Methods and material for containment and cleaning up

Small spill

Section 8. Exposure controls/personal protection

Where organic vapours are a potential hazard during metalworking operations, a combination particulate and organic vapour filter may be necessary.

Respiratory protection equipment should therefore be chosen in consultation with the supplier/manufacturer and with a full assessment of the working conditions.
