## Section 6. Accidental release measures

### Methods and material for containment and cleaning up

**Small spill** Stop leak if without risk. Move containers from spill area. Absorb with an inert material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.

**Large spill** Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas. #### Hand protection
